GOVERNMENT SUGGESTIONS RESPECTING REVISION OF CHARTER

Mr. Lincoln M. Alexander (Hamilton West): Mr. Speaker, I wish to direct a question to the Secretary of State for External Affairs with regard to the forthcoming visit of the Secretary General of the United Nations. Does the government have any suggested revisions to the United Nations charter and will these be given some publicity prior to the visit of the Secretary General? Does the minister have in mind any suggestions with regard to revision of the charter?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Yes, Mr. Speaker. The subject of charter revision is now under consideration in the department. Before the time expires, I will be presenting our views on the subject to the Secretary General. The hon. member knows that the prospects of substantial charter review are almost nil because most of the great powers and most of the under-developed countries in the world are opposed to revisions in the charter of the kind that have often been suggested to me. However, we will be putting forward what we think are practical proposals in this direction. I do not think, however, that this will be a main subject of discussion with the Secretary General when he is here.

STATEMENT BY U.S. SENATOR RESPECTING AGREEMENT BY CANADA, UNITED STATES AND MEXICO ON CONTI-NENTAL WATER POLICY—INQUIRY AS TO DISCUSSIONS

Mr. David Lewis (York South): Mr. Speaker, my question is for the Acting Prime Minister, either in that capacity or in his capacity as Secretary of State for External Affairs.
