*NUMBER OF STUDENTS WHO WILL QUALIFY UNDER NEW PROVISIONS OF UNEMPLOYMENT INSURANCE ACT

Question No. 1,588-Mr. Fairweather:

What is the estimated number of school or university students who will qualify for Unemployment Insurance when they return to classes under the new provisions of the Unemployment Insurance Act?

Mr. J. A. Jerome (Parliamentary Secretary to President of the Privy Council): School or university students who return to classes are not eligible for unemployment insurance benefits because they are not available for work as required under the Unemployment Insurance Act. There is no estimate of the number of school or university students who do not return to the full-time attendance of classes and are unemployed. The latter students could qualify for benefits if they worked in insurable employment for eight weeks in the past 52 weeks.

COVERAGE OF CONSTITUTIONAL CONFERENCE IN VANCOUVER

Question No. 1,622-Mr. Mather:

How many CBC staff members were in Victoria to cover the Constitutional Conference?

WAR VETERANS ALLOWANCE TO VETERANS LIVING OUTSIDE CANADA

Question No. 1,658-Mr. MacRae:

Is the government giving consideration to amending the War Veterans Allowance Act so that war veterans living outside of Canada, especially in the United Kingdom and in the United States of America, would be permitted to draw War Veterans Allowance without having to return to Canada?

Hon. Jean-Eudes Dubé (Minister of Veterans Affairs): Section 3(3) of the War Veterans Allowance Act, as amended in 1960, reads as follows:

- "3. (3) Notwithstanding subsection (1), the allowance payable under this section to a veteran, widow or orphan may be paid to that veteran, widow or orphan who absents himself from Canada after the coming into force of this Act if, on the day that he leaves Canada, he
- (a) is a recipient of an allowance under this section or section 5; and
- (b) had been resident in Canada for the twelve months immediately preceding that day."

The foregoing provides that such a recipient can normally continue to receive his allowance indefinitely outside Canada

The government is not giving consideration to amending the War Veterans Allowance Act at this time.

RIDING MOUNTAIN NATIONAL PARK—ZONING POLICY

Question No. 1.704-Mr. Stewart (Marguette):

- 1. Is the zoning policy still in effect in Riding Mountain National Park?
