#### CLOSING OF HAWKER SIDDELEY FORGE OPERATION—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION

**Mr. Elmer M. MacKay (Central Nova):** Mr. Speaker, I rise pursuant to Standing Order 43 on a matter of urgent and pressing necessity. In view of the action presently under way by the management of Hawker Siddeley Canada Limited to dismantle their forge at Trenton, Nova Scotia, the largest such operation in Canada, in view of the great strategic and industrial importance of this unique facility to Canada, and in view of the possible efforts that this course of action will have on the work force of Hawker Siddeley's Trenton operations, as well as the interests of the industries which have grown to depend on the capacity of this forge for special projects, I move, seconded by the hon. member for Egmont (Mr. MacDonald):

That the Minister of Regional Economic Expansion and the Minister of Industry, Trade and Commerce forthwith instruct the management of Hawker Siddeley Canada Ltd. to immediately cease the dismantling of this unique forge and the machine shop used in connection therewith, until suitable alternatives have been discussed and arranged.
