Ouestion No. 1.421-Mr. Jones:

- 1. Is the Manual on Isolation Training available to civilian health personnel and, if so, when will it be available?
- 2. Is the Department of National Defence preparing this bulletin?
- 3. Does the department feel that a core of isolation trained experts would be advisable in all provinces and territories and, if so, would periodic refresher courses not be required in this regard?
- Hon. Barney Danson (Minister of National Defence): 1 and 2. A training manual for the maintenance and operation of the "Containment Bed Isolator" is being written at this time and is expected to be completed by mid-1979. A second piece of isolation equipment, the "Transit Isolator" is being evaluated by DND and a manual will also be prepared for this equipment, however, no date is available for its completion. Both manuals will be available to civilian health personnel.
- 3. Yes. Until such time as provinces develop their own expertise for local training DND nursing personnel will be available to offer refresher training on an as-required basis to those agencies acquiring isolation equipment.
