Oral Questions

FREEZER-TRAWLER LICENCES OFF EAST COAST

Mr. Haliburton: I recommend it to members. Information was given to me in my riding which indicated that there are in existence, in the province of Nova Scotia, two freezer-trawler licences held by people in that province.

**Mr. Haliburton:** My question to the minister is simply: Is it a fact that there are in existence freezer-trawler licences off the east coast of Canada? If so, how many are there, and when were they issued?

Hon. James A. McGrath (Minister of Fisheries and Oceans): Mr. Speaker, the hon. member is quite correct; the only freezer-trawler licences which have been issued were issued by the previous administration.

Mr. Baker (Nepean-Carleton): Oh!

Mr. McGrath: At the present time there are licences in the Atlantic provinces for four freezer-trawlers. The policy of this government on freezer-trawlers will be announced in due course.

## REGIONAL ECONOMIC EXPANSION

DESIGNATION OF SPECIAL ZONES—REQUEST CERTAIN MUNICIPALITIES BE NOT DESIGNATED

Mr. Antonio Yanakis (Berthier-Maskinongé): Mr. Speaker, my question is for the Minister of Regional Economic Expansion.

June 30, 1980, is the expiry date of the order relating to special zones which came into effect on July 1, 1977, and which applies to the Montreal area and satellite localities. The minister said in the House recently that the new policy relating to the special zones of Montreal is actually under close consideration in his department and that a new program will soon be announced.

In light of the fact that the program relating to these Montreal special zones has proven to be a near failure since 1977 as far as the establishment of new industries in this area is concerned, will the minister consider making municipalities located within 50 or 100 miles of Montreal independent from this special area, since these towns should never have been considered as satellites of Montreal? I am referring, for instance, to the counties of Berthier and Joliette, whose economies are disturbed because of a bad recommendation by technocrats.
