By having the definition of sustainable development right in the body of the bill, the guidelines for all policy related to the forests of this country are crystal clear.

I think that his constituents and the people of Canada should realize that sometimes even though it may be perceived to be a minor amendment, in actual fact it can have quite a substantive and profound influence on policy development in this country.

I salute my colleague for his work in this particular sector of our economy. It is so important to all of us.

MONTREAL BOARD OF TRADE ACT

MEASURE TO ENACT

Hon. Bob Layton (Lachine—Lac-Saint-Louis) moved that Bill S-12, an act to amalgamate the Montreal Board of Trade and the Chamber of Commerce of Metropolitan Montreal, be read the second time and, by unanimous consent, referred to Committee of the whole.

He said: Mr. Speaker, we are asked to approve this historic legislation giving effect to the merger of the Montreal Board of Trade with la *Chambre de commerce du Montréal métropolitain*. Both groups have been closely associated with the social, cultural and economic development of Montreal and its regions, including the province of Quebec and Canada as a whole, for over a century.

The decision to combine their strengths by respecting the traditions and heritages of both founding associations sends out a positive signal as to the attitude currently prevailing in Montreal's business community. In fact, the merger decision was unanimously approved by the members of both groups on March 23 of this year.

One aspect of this merger that should be pointed out is that under the official by-laws contained in the enabling legislation, this new structure will operate in Canada's two official languages. At this crucial time in our history, I think that is worth mentioning and worthy of our hearty commendation.
