EARLY MARRIAGES SUPPORTED AND OPPOSED IN LEGISLATURE

Interesting Discussion of New Marriage Laws—Is Charlotte County a Gretna Green? — Mr. Smith Denies the Impeachment — Hon. Mr. Veniot Looks for More Trouble and Finds It.

Special to The Standard. (From Official Report). Fredericton, June 5.—The house met at three o'clock. Mr. LeBlanc presented the report on municipalities.

Mr. Speaker said that he had ruled the enquiry out of order and there was nothing more to be said. Hon. Mr. Murray said that he would have to appeal to the house from the Speaker's ruling.

Hon. Mr. Veniot in replying to an enquiry by Hon. Mr. Smith (Carleton) took exception to the wording of it. He said he didn't do so from any desire to evade the information asked for because he was going to give it but the enquiry contained a statement of fact as was the case with many other enquiries which was not allowed by the rules. The statement in that particular enquiry was that the bridge referred to was in a dangerous condition.

Mr. Speaker said that under parliamentary ruling that the word dangerous was not allowable in an enquiry. The enquiry was therefore out of order.

Another Ruling By Chair. Hon. Mr. Murray (Kings) said he had no desire to question the Speaker's ruling but the statement referred to was hardly one of fact in the ordinary acceptance of the term. It was merely a statement made upon which to base the enquiry and he did not see how it could have been made in any other manner in order to get the information which he wanted.

Veniot Trouble Maker. Mr. Murray said that he had no desire whatever to raise any question but enquiries in a similar form to that complained of had always been allowed in the past as the hon. member from Moncton had said and no objection had been taken and he could not refrain from remarking that the minister of public works had gone out

of his way to make trouble unnecessarily. Mr. Speaker said that as long as he occupied the chair he wanted to run the house according to the accepted rules of procedure. The reports of the doings of the house were published all over the province and outside the province and if they did not follow the rules they would only bring their proceedings into contempt.

Hon. Mr. Baxter said that Mr. Speaker would undoubtedly have the support of the members on both sides in his desire to conduct the business of the house in a proper manner. He thought in the enquiry referred to the language (Continued on Page 4)
