II. And be it further enacted, That all Sales or Bargains for the Sale of any Negro, Sales of Negroes, Household Furniture, Utensils of Husbandry, or Clothing so imported, which shall &c. so imported be made within Twelve Calendar Months after the Importation of the same (except Months, to be void. in Cases of the Bankruptcy or Death of the Owner thereof), shall be null and void to all Intents and Purposes whatsoever.

III. And be it further enacted, That every White Person so coming to reside, if All White Persons above the Age of Fourteen Years, shall and he is hereby required, immediately after coming so to reside, his Arrival, to take and subscribe the Oath of Allegiance to His Majesty, His Heirs Allegiance, if upand Successors, before the Governor, Lieutenant Governor, or Chief Magistrate of wards of Fourteen the Place where such Person shall arrive, and at the same time swear that it is his Years old. Intention to reside and settle in such Island or Province; for which Oaths such Governor, Lieutenant Governor, or Chief Magistrate, shall receive the same Fee, and no more, as is payable by Law on administering the Oath of Allegiance in Cases where the same is now by Law required.
