- 1. House resolves to go into Committee of Ways and Means, 18. resolves itself accordingly, 51. Certain Resolutions imposing additional duties of Excise on malt and beer, and making certain changes in duties of Customs on ale, beer, porter, tea, oils, &c. To be reported, 53; Reported, 95; amendment proposed by Sir J. A. Macdonald—That the House regrets that the financial policy submitted by the Government increases the burthen of taxation, &c., 97. Amendment proposed by Mr. Wallace to substitute an ad valorem duty; passed in the negative, 225. Resolutions read second time and agreed to, 224-226. (Special entry made with respect to an apparent irregularity in previous proceedings, 336) Amendment proposed by Mr. Rochester for reduction of duty on malt; passed in the negative, 337. Read third time and passed, 337. By the Senate, 353. R. A. 359. (40 Vic., c. 11.)

Bill to grant to Her Majesty certain sums of money required for defraying certain expenses of the Public Service for the financial years ending respectively 30th June, 1877, and 30th June, 1878, and for other purposes relating to the Public Service; Ordered; Presented, 352. Passed all its stages, 353. By the Senate, 357. R.A. 360 (40 Vict, c. 1.
