CLEVELAND'S OPINION

Ex-President Gives His Views on Cuban Question.

York, Pa., Jan. 22.—A. B. Farquhar of this city, head of the Farquhar Agricultural Works and prominent in national Democratic affairs, has received the following letter from ex-President Cleveland in answer to one sent him by Mr. Farquhar, relative to the relations of the United States with Cuba:

"Westland, Princeton, N. J., January 31.

"My Dear Mr. Farquhar: I have only sufficiently recovered from my illness to be about a little and ride out in a limited way."

"I received your letter yesterday and was much impressed by the manner in which you discuss our relations and our duty to Cuba.

"The obligations arising from these considerations cannot be better or more forcibly defined than was done by President Roosevelt in his message to congress, nor better emphasized than has been done by Secretary Root and yet congress waits, while we occasionally hear of concessions which rich sugar interests might approve in behalf of trembling Cuba.

"I do not believe that nations, any more than individuals, can safely violate the rules of honesty and fair dealing.

"Until there is no escape therefrom I will not believe that, with all our fine words and lofty professions, our embrace of Cuba means the contagion of deadly disease. Yours truly,

Fate of a Sloop.

Believed to be in Custody at Creede, Colorado.

Creede, Col., Jan. 18.—Officers here firmly believe that they have in custody Pat Crowe, who is wanted in Omaha for the kidnaping of Eddie Cudaby.

He also had on his person a ring which assisted in his identification, it being a three-stranded silver ring set with an imitation turquoise.
