4. Do these agents make periodical reports ? If so, at what periods ?

2. W. L. Nichols, appointed 3rd October, 1903, remuneration, \$825 per annum. Samuel Hagan, appointed 9th February, 1892, as Indian Lands Agent, and from 1st February, 1899, as Indian Agent, with remuneration of \$500 per annum. C. L. D. Sims, appointed 21st October, 1898, remuneration, \$1,000 per annum. Robert Thorburn, appointed 16th May, 1903, remuneration, \$600 per annum.

I think we were promised by the First Minister that if he could conciliate his colleague the Minister of the Interior, we should have produced a copy of the order in council said to have been passed by the Yukon council in reference to the rain maker. As the time comes on for these operations to commence our anxiety deepens and we would like very much to know that all the points are well guarded with reference to that transaction.

The other day, the hon. member for Yale-Cariboo (Mr. Ross) appears to have quoted from an order in council of April 21, 1901, relating to colonization lands. I do not know whether he quoted from the departmental copy or not, but I have not been able to find that order in council anywhere. If it is anywhere I would like to know where it can be found. If it is not in the records, I should like to have it brought down as it is an important document in this debate.
