a white paper would be necessary. Certainly I would not put it on slides. What I should like to do is put the amendments on the Order Paper as soon as possible. However, this again will depend on the speed and dispatch with which we clean up legislation already on the Order Paper.

## POLLUTION

DUMPING OF OIL AND OTHER WASTE IN GREAT LAKES

Mr. W. B. Nesbitt (Oxford): Mr. Speaker, I have a question for the Minister of Transport relating to the greatly increasing concern over continued dumping of oil and other waste from ships in the Great Lakes, in contravention of the Fisheries Act. What efforts has the government made to increase surveillance so that a greater proportion of major offenders are promptly prosecuted?

Mr. Speaker: Order. I would think this question should be placed on the order paper.

Mr. Nesbitt: Mr. Speaker, with great respect, may I draw Your Honour's attention to the fact that before very long the shipping season on the Great Lakes will be completely closed, and complaints that oil is being dumped into the lakes are constantly being made. I should have thought that the minister would have a reply.

## TRANSPORT AND COMMUNICATIONS

REFERENCE TO STANDING COMMITTEE OF CNR FINANCIAL STRUCTURE AND PENSION FUND

Mr. John L. Skoberg (Moose Jaw): Mr. Speaker, I have a question for the President of the Privy Council. In view of the discussions that have taken place in relation to the business coming before the House today, would the minister be prepared to move a motion forthwith giving the Standing Committee on Transport and Communications terms of reference to study the financial structure of Canadian National Railways and the CNR pension fund, with provision for calling witnesses as determined by the committee?
