REPLACEMENT OF PUBLIC ORDER (TEMPORARY MEAS-URES) ACT—OPPORTUNITY FOR DEBATE

Mr. G. W. Baldwin (Peace River): I have a question for the Minister of Justice. As there are only six more parliamentary days before April 30—I am sure the minister is well aware of that—can he advise the House if the internal difficulties that the government has experienced in connection with the type of measure to replace or deal with the Public Order (Temporary Measures) Act have been resolved? Hon. John N. Turner (Minister of Justice): Mr. Speaker, I am not going to accept the preamble to that question. The Prime Minister dealt fully with the same question yesterday. Certain issues will be brought before the House in such a form that the views of the House may be ascertained.

COMPULSORY PROVISION OF STRONGER BUMPERS ON AUTOMOBILES
