**MANPOWER****LOCAL INITIATIVES PROGRAM—APPLICATION DATE CONSIDERED IN MAKING GRANTS—ADDITIONAL FUNDS**

**Mr. S. J. Korchinski (Mackenzie):** Mr. Speaker, my question is for the Minister of Labour. In view of the number of applications that have gone to his office in connection with the local initiatives program, is the original date of application considered for the granting of loans or is it the final date which is considered as the date of application in the granting of loans? I ask this question since there apparently is a shortage of funds available for the program.

**Hon. Martin P. O'Connell (Minister of Labour):** Mr. Speaker, I will try to clarify the two dates that the hon. member has in mind and have a conversation with him on this.

**Mr. Korchinski:** Mr. Speaker, may I ask the minister if the government intends to devote additional funds to this program in order to make it workable inasmuch as people have become excited about the program and made applications and the program now cannot fulfil the requirements?

**Mr. O'Connell:** Mr. Speaker, it is true that a very large response was made to this offer of opportunities for work. There is no present intention to increase the funds in the program.

**Hon. Martin P. O'Connell (Minister of Labour):** Mr. Speaker, I am very happy to note, in looking at the range of projects, that a great number of them, particularly in Newfoundland, involved what the hon. member likes to describe as isolated communities.

**Mr. Speaker:** The hon. member for Nanaimo-Cowichan-The Islands. I apologize to the hon. member. Perhaps I might first recognize the hon. member for Oxford on a supplementary and then the hon. member for Nanaimo-Cowichan-The Islands.

**Hon. Martin P. O'Connell (Minister of Labour):** Yes, Mr. Speaker, I believe that both those conditions are in the criteria. I will check on that, but I think I am correct.
