

### CONSUMER AFFAIRS

#### FOOD PRICE INCREASES—REQUEST THAT PRIME MINISTER MEET FARM ORGANIZATIONS TO OBTAIN VIEWS—MEETING WITH WESTERN PREMIERS

**Mr. A. P. Gleave (Saskatoon-Biggar):** Mr. Speaker, may I direct my question to the Prime Minister. In view of the finding of the food committee that the producer is suffering as much as the consumer from the fact that prices between the farm gate and the consumer continue to widen, will he meet with farm organizations in order to obtain the benefit of their views on current trends in prices?

**Right Hon. P. E. Trudeau (Prime Minister):** Mr. Speaker, the cabinet met less than three weeks ago with two farm organizations which made representations to cabinet on this and many other matters. I am always prepared to meet with representative organizations.

**Mr. Gleave:** May I ask the Prime Minister if, in view of the recent meeting of the four western premiers in which they expressed some unhappiness over the treatment that western Canada is now getting from Ottawa, he will contact the western premiers in order to ensure that there will be a meaningful exchange of views and concrete action at the forthcoming meeting next July with regard to some of these problems?

**Mr. Trudeau:** Mr. Speaker, surely the House realizes that it is the federal government that initiated these meetings and suggested they were necessary to meet problems that exist in the west. Therefore the hon. member's enjoinder should be addressed to the premiers rather than to this government.

Is the minister in a position to inform the House today whether the government will make it a requirement in the future that companies receiving financial assistance of any form from the federal government, will give the government of Canada some degree of equity in the corporation, as a consideration for the assistance?

**Hon. Donald C. Jamieson (Minister of Regional Economic Expansion):** Mr. Speaker, this is one of several facets of the changes in the Regional Development Incentives Act that we are considering. The hon. member and I have had conversations on this. There are cases where it is an attractive proposition and, where that exists, we are certainly prepared to exercise that option.

#### ALLEGED TUBAL LIGATION OF NATIVE WOMEN WITHOUT THEIR KNOWLEDGE OR AGAINST THEIR WILL—PROVISION OF INTERPRETER
