### FUND RAISING BY PROGRESSIVE CONSERVATIVE PARTY

Mr. Don Boudria (Glengarry-Prescott-Russell): Mr. Speaker, as part of the Conservative Party's fund raising efforts of last year, my constituents received appeals from the Prime Minister (Mr. Mulroney), the then Leader of the Opposition, to contribute sums of \$50, \$100, \$150, or \$350 to his campaign. In this appeal he criticized the Liberal Government for high unemployment, lack of foreign investment, and poor economic conditions in Canada. In November, 1983, he said:

#### INTERROGATION OF DETAINED IRANIANS

Mr. Dan Heap (Spadina): Mr. Speaker, today The Globe and Mail reported that the Iranians who were detained near Pearson Airport were interrogated by unidentified police. We were not told on what authority they were detained nor who authorized the detention. We are given to understand that no lawyer representing the people being interrogated was present at the interrogation. This sort of thing could happen to any of us. It could even happen to Canadian citizens on Canadian soil. It may be the work of the secret police force that was established last June under Prime Minister Trudeau.

I call upon the Minister of Employment and Immigration (Miss MacDonald) to broaden the inquiry she has undertaken so that it will examine all places at which those arriving in Canada may be detained, who orders such detentions, and under what criteria, and what provision is made for acquainting detainees with their rights under our Charter of Rights and Freedoms. With particular regard to The Globe and Mail story, the inquiry should find out who carried out the interrogation and who authorized the entry of the police into the detention centre. As well, it should determine whether or not those who were interrogated were informed of their rights under our Charter of Rights and Freedoms, and whether or not they were given an effective opportunity to exercise their rights by retaining a lawyer to act in their interests.

According to The Globe and Mail, what is reported was based on affidavits, and constitutes a very serious danger to our rights and freedoms from this newly-minted secret service. It is important to-
