## COMMUNICATIONS

Mr. Ronald J. Duhamel (St. Boniface): Mr. Speaker, I wish to table a petition in which your petitioners call upon Parliament to ensure no inappropriate language is used or acts of violence are displayed on radio or television. They say that often what they see and hear undermines the way they are trying to raise their families.

They also stressed it was unnecessary to use inappropriate language or to encourage acts of violence in order to inform people, in either official language.

#### CANADA STUDENT LOANS PROGRAM

Mr. Ronald J. Duhamel (St. Boniface): Mr. Speaker, I also have a petition from petitioners in Saskatchewan who are part of the Canadian Federation of Students which represents over 450,000 students across Canada. They ask the government to remove the 3 per cent tax on student loans and not to permit Bill C-76, which would add 6 months interest, to go through.

They also ask the government to be particularly cautious about transferring the student aid program to banks. They would like to have a role to play in it. If that is going to happen they would actually prefer to see it abolished.

#### GOODS AND SERVICES TAX

Mr. Ronald J. Duhamel (St. Boniface): Finally, Mr. Speaker, I have another petition that asks the government to seriously consider the withdrawal of the GST on books and reading materials.

They point out that there has never been such a tax and it is contrary to what we want in a democratic society such as ours. As well it runs contrary to objectives such as increased productivity and competitiveness.

#### VIOLENCE

Mr. Guy Saint-Julien (Abitibi): Mr. Speaker, I would like to table a petition from residents of Amos, Saint-Félix, Saint-Dominique-du-Rosaire, Senneterre, Rivière-Héva, Saint-Mathieu and Val d'Or, in the riding of Abitibi, who say that films depicting violence on television are dangerous and therefore unacceptable because they act as a stimulus for violent behaviour.

The petition also says that all toys that incite children to play violent games are unacceptable and their manufacture should be banned. It is also pointed out that the repeated broadcasting of news about acts of violence on television, on all channels, and on radio may act as a stimulus for further identical violent behaviour.

Therefore your petitioners humbly pray and call upon Parliament to pass the appropriate legislation in order to eliminate violence in our society and thus protect our children and give all citizens a better quality of life.

### **BOSNIA-HERCEGOVINA**
