#### IMPORT PERMITS—EGGS

##### Question No. 2,929—Mr. Beatty:

1. How many different companies received import permits for eggs during the period January 1, 1976 to May 31, 1977?
2. During the same period, how many import permits were issued to each company?
3. What was the quantity of eggs imported by each company during the period?

**Mr. Hugh Poulin (Parliamentary Secretary to Minister of Industry, Trade and Commerce):** 1. There were 188 companies issued with import permits to import eggs into Canada during the period January 1, 1976 to May 31, 1977.

2. In view of the commercial confidentiality that is attached to permits issued to import goods listed on the Import Control List, it is not possible to divulge how many import permits were issued to each company to import eggs during the period January 1, 1976 to May 31, 1977. However, during the same period, a total of 330 permits were issued to 188 companies.

3. A total of 655,560 boxes, containing 15 dozen of eggs each, were authorized for importation into Canada during the same period.

2. Were discussions held in relation to the moves with the (a) local governments in the cities (b) provincial governments in the provinces to which such units will move, prior to the date the moves were announced and, if so, in each case, what were such discussions?

##### Hon. Robert K. Andras (President of the Treasury Board):

1. Discussions were held with the Public Service Alliance of Canada either at the national level or component level prior to the date of the relocation announcement of the government units listed in Part 1 of question 2,931. Discussions were held on such matters as the number of staff-years to be relocated, the identity of the work unit to be relocated, the name of the receiving community, the expected date of the relocation, and/or the expected date of the public announcement.

2. Discussions with the local and provincial governments were not held prior to the dates the relocations were announced.
