Montreal, Oct. 22-The following cable has been received here from Colonel Fred Burnham of Winsipag-who went out to Stheria in charge of a Red Cross mission: "The Serbiant are destroying Albania and Monten-egro with fire and sword. Thirty thic, sand refugees from Dibra are now in Thrania, the capital of Albania. All the district of Dibra and bait the dis trict of Mathia, are destroyed. In the district of Dibra alone 4,000 houses have been burned by the Serbians."
