SCHULLER Reg. No. C/551, ex-C/M Katharina Schuller, 77, died October 4, 1997, at Montréal. She was born December 16, 1919, at Vukovar, Yugoslavia, and joined the Force as a civilian member translator July 22, 1968, at Vancouver. Schuller was posted to "C" Division, Que., at Montréal, where she worked until she took her discharge on July 15, 1984.

SLATTERY Reg. No. 12369, ex-C/S/M John Patrick Slattery, 84, died November 11, 1997, at Victoria, B.C. He was born January 23, 1913, at Moose Jaw, Sask., and joined the Force June 5, 1934, at Edmonton, Alta. Upon completion of training at "Depot," Slattery was posted to "E" Division, B.C., where he worked at Vancouver. On October 31, 1938, he was transferred to "D" Division, Man., at Winnipeg, and took his discharge October 24, 1939. STEVENSON Reg. No. 0.392 (12370), A/Commr. Edward Hammond Stevenson, MBE (retired), 84, died December 29, 1997, at Cloverdale, B.C. He was born February 20, 1913, at Grand Fords, B.C., and joined the Force June 5, 1934, at Vancouver. Upon completion of training at "Depot," Stevenson was posted to "N" Division, taking his discharge June 4, 1938.
