Fight Between Soldiers and
Civilians.

HALIFAX, Jan. 31.—A correspondent
writing from Kingston, Jamaica, gives
particulars of a riot caused by soldiers on
the race course at Fletcherland, which
resulted in nearly a hundred of them being
thrown into prison. A row was started between about 80 soldiers of the West India
Regiment in compact Kingston, Ja tween about 80 soldiers of the West India Regiment, in camp at Kingston, Jamaica, and a few constables, the upshot of which was that one of the latter received such injuries that he had to be conveyed to the hospital. Subsequently a sally was made on the Fletcherland police station, and there a regular bombardment took place. The police, only numbering four, retaliated with stones which happened to be lying in the yard. At last, however, when the police were on the verge of being annibilated, the fire alarm was rung and a large posse of constables arrived in charge of Inspector Wedderburn. The latter was, however, struck on the head with a brick and knocked off his horse. The alarm unfortunately brought a number the contraction of the contraction of the same with a brick and knocked off his horse. The alarm unfortunately brought a number of loose women to the spot, and they encouraged the soldiers to redouble their efforts against the police, at the same time supplying them with stones. The ammunition at length failing, a portion of the soldiers began to lose heart and fled. Shortly afterwards a picket of soldier arriving on the scene, with an officer at their head, put an end to the riot. Several soldiers were captured and placed in custody.
