Chief Justice Lemieux immediately discharged the jury and instructed that a new panel be called for a new trial that he ordered for the next sittings of the general assizes in Sentember.

Montreal, July 23 .- The fate of the Rev. Adelard Delorme, alleged slayer of his half-brother, Raoul, still hung in the balance early this afternoon. Forty-two hours after the case had been placed in their hands, the jury at 11:15 this morning reported themselves unable to agree upon a verdict. Chief Justice Sir Francois Lemieux instructed them to retire until 3 o'clock this afternoon, with the assurance that they would then be discharged if a verdict was not forthcoming.

"The jury have the honor to report to your lordship that we cannot come

No fines for prisoners being held here will be accepted at any other time. I will be here during these hours, and this scheme will take a load off the turnkeys' minds,"


