Boundary Blunder.

Sir Wilfrid's Statement to the Commons Flatly Denied at Washington.

First Heard There of Establishing Customs Post on Dalton Trail.

Canada Would Locate a Boundary "by Some Unrecognized Mountain Peaks."

Washington, June 6.—The statement in the Canadian parliament by the Premier yesterday, to the effect that the Canadian government has proposed to the Americans to establish a custom house on the Dalton Trail and regard it as the provisional boundary there, causes great surprise here.

The officials assert that this is the first they had heard of any such proposition. The last Canadian proposition, it is said, embodied a vague proposition to locate a provisional boundary by some unrecognized mountain peak, but contained no reference to the Dalton Trail custom house.

SCHEME FOR MEDIATION.

Provisions of Draft Adopted by Committee—Russian Naval Suggestions Rejected.

The Hague, June 6.—The naval section of the armaments committee have unanimously rejected the Russian proposals.

Article 5 provides that independently of a recourse to such amicable means, any friendly power may offer good offices of mediation without such offer being considered an unfriendly act.

Article 6 says that the good offices contemplated are that the mediator shall consist of a friendly country.

Article 8 says that during 30 days the mediator in dispute shall be considered as referred exclusively to the mediatory powers.

The Grab For Alaska.

Sir Wilfrid Reads in House Americans' Demand for All Territory.

Opposition Leader Commends Ministers for Cutting Short the Negotiations.

MR. SIFTON SHOWN HARM DONE BY HIS TOO READY TONGUE.

WASHINGTON, June 5.—The first business in the house to-day was the production by the Premier of the Alaska and Yukon boundary protocol. The statement read by him is the same as has appeared in the press.

Mr. Sifton referred to the documents only so far as to show the difference between the British and United States proposals. These differences are two.

Mr. Sifton pointed out that the authorized statement at the time the negotiations ceased was that the proceedings had been entirely arrested, with the intention of not resuming unless the Alaska boundary question in connection with this fact now disclosed places the Canadian commissioners in a better light than their previous attitude in London.
