Veterans Affairs (Special) Committee:

1. Motion, Mr. Lapointe, that a committee be appointed to consider any legislation relating to veterans affairs that may be referred to the committee; moved, 597. Amendment, Mr. Brooks, to empower the committee to consider the War Veterans Allowance Act, ruled out of order on the ground that an amendment cannot be moved to give a committee wider powers than those set out in the notice of motion, 599. Amendment, Mr. Hansell, to empower the committee to consider matters relating to veterans affairs as the committee may decide; amendment ruled out of order in that it was not in order to move an amendment which would give a committee wider powers than those set out in the notice, 601. Main motion agreed to, 601.

Veterans Benefit Act, Bill:

Bill No. 101, Mr. Lapointe, An Act respecting Benefits for Members of the Canadian Forces; 1st R., 133. 2nd R., 297. Referred to *Special Committee on Veterans Affairs*, 297. Reported with recommendations, 701. Evidence presented and recorded as appendix No. 12 to the *Journals*, 741. Resolution,—To amend the proposed measure respecting Benefits for Members of the Canadian Forces, Bill No. 101, by substituting for paragraph (c) of sub-clause (2) of clause 12, relating to the Unemployment Insurance Act, the following: (c) every person who was a member of the regular forces on and immediately prior to the fifth day of July, 1950, etc.; Considered in committee of the whole forthwith, 712. Resolution adopted, 712. Referred to Committee of the whole on the said Bill No. 101, 712. Bill reported from committee of the whole with an amendment, 718. 3rd R., by leave, 718. Passed by Senate, 812. R.A., 866. (2-3 Elizabeth II, Chapter 65).
