EMPLOYMENT-MARITIME PROVINCES

Mr. STANFIELD:

1. Has the Department of Labour offered or assisted in securing employment in other prov-inces of Canada for persons in (a) Nova Scotia;

(b) the maritime provinces during the calendar year 1947 and 1948 to date? 2. If so, how many persons left (a) Nova Scotia; (b) the maritime provinces to take up positions in other parts of Canada?

Mr. COTE (Verdun):

HARNESSING OF BAY OF FUNDY TIDES

Mr. BROOKS.

1. Has the government or any department thereof received any communication from the United States department of the international boundary commission recommending the joint investigation of the possibility of a Canadian-American endeavour to harness the tides of the bay of Fundy at Passamaquoddy? 2. If so, what was the nature of the corre-

spondence and what action, if any, does the federal government intend taking?

Mr. ST. LAURENT:

1. On May 21 I received from the United States charge d'affaires in Ottawa a communication regarding the Passamaguoddy tidal power project.

2. In his note, the charge d'affaires inquired whether it would be agreeable to the Canadian government to make a joint reference of this project to the international joint commission for investigation, exploration, survey and report as to its practicability, public convenience and necessity. He added that draft terms of reference would, in due course, be forwarded to the Canadian government for consideration. I replied on May 29, noting the proposal that this matter be studied and that draft terms of reference will be forthcoming and indicated that the proposal for a reference to the international joint commission would receive careful consideration by the appropriate Canadian authorities.
