REPORTED INTENTION TO CUT INCOME TAX TO STIMULATE GROWTH

Hon. Walter L. Gordon (Minister of Finance): Mr. Speaker, I do not know to whom the right hon. gentleman was referring when he mentioned a statement made outside the house. May I ask him to give me a little more information?

Mr. Diefenbaker: I cannot give particulars except to say that the hon. member for Coast-Capilano, parliamentary secretary to the Prime Minister, made a speech and the heading of the report is "M.P. Hints of Cut In Income Tax". The report contains this statement:

If various tax incentives and cheaper money policies are not effective, an across the board cut in taxation may be desirable.

Mr. Gordon: Mr. Speaker, I can assure the right hon. gentleman that when the government has any announcements to make on this subject it will do so in the house.

Mr. Diefenbaker: I rise on a question of privilege. That is the reason I asked this question. Did the parliamentary secretary have any authorization to speak in this way on behalf of the government?

Mr. Gordon: On the basis of the extract from the newspaper report which was read it seemed to me that the parliamentary secretary was discussing economic theory in a general way, and I think he has every right to do so.

Mr. Diefenbaker: Parliament by-passed again.
