UNITED STATES IMPORT SURTAX—CHANNEL OF CANADIAN REPRESENTATIONS TO U.S. GOVERNMENT

Mr. R. N. Thompson (Red Deer): Mr. Speaker, I wish to direct a question to the Minister of Finance. STEPS TO IMPROVE SERVICE AND AVOID EXORBITANT COST FOR MAILING LETTERS

Hon. W. G. Dinsdale (Brandon-Souris): My question, Mr. Speaker, is for the Postmaster General. In light of the statement by a senior official of his department, as well as by the hon. member for Winnipeg South Centre, that within nine years Canadians will be paying 26 cents to mail a letter in Canada, continuing the upward spiral that began in 1968, will the minister indicate what steps he is taking to improve the service so this exorbitant cost will be avoided?

Mr. Speaker: Order, please. The hon. member must recognize that he is dealing with a situation that may happen in nine years time and so the question should perhaps be placed on the order paper. In any event, he is asking for a general statement and I would think that kind of statement normally ought to be made on motions. The hon. member might like to rephrase his question along those lines.

Mr. Dinsdale: Thank you, Mr. Speaker, for your admonition. I deliberately included the phrase, "the upward spiral that began in 1968." In view of the fact that the postal service is the basic communications system in Canada, would the minister indicate what steps he is taking to avoid this continuation of exorbitant costs?

Mr. Speaker: Order, please. The hon. member is simply repeating the question he asked in the first instance, and I [Mr. Benson.]

told him that the question was not in order asked in those terms.
