MINISTRY OF TRANSPORT BUILDING-MONCTON, NEW

Question No. 1,360—Mr. Jones:

- 1. On what date and at what location will the proposed new old building for the Department of Transport in Moncton, New Brunswick be decided?
- 2. What site was recommended for the DOT building in Moncton?
- 3. What were the names of the tenderers and the amounts bid for the last tender call for the DOT building in Moncton?
- 4. (a) For what reason were tenders not accepted (b) for what reason was construction not commenced?
- 5. (a) Are tenders to be called again and, if so, on what date and at what location will the new DOT building be built (b) what is the estimated cost?

Mr. Alexandre Cyr (Parliamentary Secretary to Minister of Public Works): 1. At the present time an accommodation study and plan are being prepared for the city of Moncton. It is anticipated that this plan will be completed this spring. At that time the various alternatives available including the possibility of constructing a new building, will then be investigated.

2. The bid by Centennial Brunswick Limited, on their Weldon Street site, was the lowest tender acceptable to both the Ministry of Transport and the Department of Public Works. This site is within the downtown core area and was approved by the Moncton Planning Authority for high-rise developments.
