HAMILTON NEWS

WHY TORONTO LOSES INDUSTRIES NOBODY TO HELP THEM TO COME

When the Union Drawn Steel Co. Was Prospecting Hamilton Officials Husbled and Helped—Officials Here So Indifferent That Companies Go Elsewhere.

Hamilton, Jan. 2.—(Special)—It is rather by the sins of omission than commission on the part of the city officials that Toronto has lost a number of American concerns that located in Hamilton last year. It was a toss up with some of them whether they would come to Hamilton or Toronto, Toronto was the choice in some cases, but once they fell into the clutches of Assessment Commissioner Hall they had a poor chance to escape.

Managers of several of the companies were interviewed this afternoon on the subject. Mr. Mahabadi of the Union Drawn Steel Company, said that his company was undecided about a location. When they wanted was a building suitable for their purposes that they could move into, and start to manufacture while waiting for the erection of a new building. One of their wants was made known here, Mr. Hall, the mayor, and everybody else in the city, according to Mr. Mahabadi, started out to hunt up a building.

Board of Health Wants. At the meeting this evening Dr. Roberts, the medical officer, brought up the question of a new isolation hospital for contagious diseases. Liberal M.P. for St. Anne's Unseated and Cannot Contest Again—Concealment Condemned. Montreal, Jan. 2.—(Special)—Ald. Dan Galloway is no longer M.P. for St. Anne's division. He was unseated to-day by Judges Davidson and Robidoux for illegal practices, and also disqualified by the same tribunal. Galloway lost his seat because of money paid to Carters and Pinand, his political agents, and because of money paid by himself. In fact the court held that out of his own mouth the Liberal M.P. was condemning the illegal practices of the United-Quebecian and Ontario North-West election cases were briefly reviewed as giving precedents.
