indictable offence, crosses some long-established lines in our legal jurisprudence.

Honourable senators, I do not want you to feel from my remarks today that I am not completely in accord with the objectives of this piece of legislation. I am sorry if it is true that we in this country today need legislation like that. I do not think that Hyde Park in London, with all it means, with the way it builds up the great British traditions of freedom, would survive very long if legislation of this nature were introduced and enforced in Great Britain. I do not think it necessary to say that the great traditions of freedom and tolerance which we have inherited from our Mother Country are just as fresh in the minds and hearts of the Canadian people.

If and when this piece of legislation is placed on our statute books, I hope and trust it will rest there, as a section of the Criminal Code which will never be required to be enforced by criminal prosecution.
