(5.) Any person convicted of any offence against this section or any regulation made thereunder may have his licence cancelled by the Minister, and may be refused a new licence thereafter.

(6.) Licences shall not be issued to boys under sixteen years of age, except at the written request of the parents or guardians, who shall also undertake that such boys shall always, when carrying firearms, be under their supervision or that of some responsible holder of a licence.

(7.) Licences shall be in the form set out under Schedule C, the fees for which shall be as follows:-

For badge and ordinary licence to carry firearms and hunt birds and deer other than moose, wapiti, and caribou, two dollars and fifty cents:

For badge and a general licence to carry firearms and hunt game birds and animals, five dollars:

For badge and special licence to carry firearms and trap, ten dollars:

(8.) Any person taking out a general licence or special licence must, within fourteen days of date of expiration, return the licence to the Provincial Game Warden, with a statement of the number of each species of big game killed or animals trapped.

(9.) The provisions of this section shall, however, not apply to Indians or to officers and men of the Canadian Militia while carrying rifles on duty, or to temporary visitors who come for the purpose of shooting in clay-pigeon competitions, or to any officer in discharge of his duties.

(10.) Ordinary licences shall be issued free of charge to prospectors having a free miner's certificate, during the open season, while actually engaged in prospecting, and to farmers and their sons hunting on the land on which they permanently reside.

(11.) Any Game Warden, constable, or peace officer may seize any firearm found in the possession of any person not having a licence, unless he be exempt as in this Act provided, and such firearm may be confiscated by any Justice of the Peace upon conviction of the offender. 1913, c. 27, s. 9.

Powers of Magistrates, Game Wardens, and Constables.

22. It shall be lawful for any Justice of the Peace, upon information on oath that there is probable cause to suspect that a breach of the provisions of this Act has been committed, or that any of the animals, birds, or eggs, or any portion thereof, mentioned in this Act are likely to be on any premises, or on board any vessel, or in any conveyance, by warrant under his hand and seal, to authorise and empower any Game Warden, constable, or peace officer to enter and search such premises, vessel, or conveyance, and to seize any of the said animals, birds, or eggs, or any portion thereof, wherever found.

CHAP. 95.

23. It shall be lawful for any Game Warden, constable, or peace Power to search persons and conofficer to search any person whom he shall suspect of having in possession any animals, birds, or eggs unlawfully obtained, and also to stop and search any cart or other conveyance in or upon which he shall suspect that any such animals, birds, or eggs are being carried by any such person, and to search the premises of any person engaged in selling, buying, or trading, or any steamer, sailing vessel, or boat, or any hotel or restaurant; and should such Game Warden, constable, or peace officer discover any such animals, birds, or eggs as aforesaid, he shall thereupon take possession of the same and otherwise proceed as authorised by law.

GAME.

24. It shall also be lawful for any Game Warden, constable, or Pewers to search shops and other peace officer, at any time during the protected season or during places the prohibited times of sale, to enter upon the premises of any shop or any storehouse, warehouse, restaurant, hotel, or eating-house, and to search for game therein.

25. It shall be lawful for the Provincial Game Warden, under Permits to trap or kill beaver. such conditions as he shall think fit, in writing under his own hand, to issue a permit to trap or kill beaver, on satisfactory proof of such animals having done damage.

26. Any person found committing an offence against this Act Arrest of offenders without warrant. may be apprehended without a warrant by any Game Warden, constable, or peace officer, and may be forthwith taken before any Justice of the Peace to be dealt with according to law. Any officer who shall maliciously, or without probable cause, abuse his power in such proceedings shall be guilty of an offence against this Act.

26A. Any Game Warden, constable, or peace officer, while in the Passing over land. discharge of his duties, is hereby granted authority to pass over any land, whether enclosed by a fence or otherwise, provided always that any such Game Warden, constable, or peace officer shall be liable for any damage which he may cause in so doing. 1913, c. 27, s. 10.

Penalties and Forfeitures.

27. Any person offending against the provisions of this Act, or Penalties for of any regulations under it, shall be liable for each offence, on conviction thereof in a summary manner before any Justice of the Peace, in accordance with the provisions of the "Summary Convictions Act," to the following fines for the following offences, namely:-

(a.) For shooting, killing, or taking each mountain sheep during the close season, not less than two hundred and fifty dollars or more than five hundred dollars;

(b.) For shooting, killing, or taking each mountain-sheep in excess of the number allowed by this Act, not less than two hundred and fifty dollars or more than five hundred dollars:
