Preparing For The Electric Light.

A meeting of the directors of the Electric Light Company was held at the office yesterday afternoon, to prepare the way for the introduction of the electric light. It was decided to call for tenders immediately for poles and for the erection of buildings. The order was sent away today for the engine and boiler. It is not yet definitely settled what system will be used, but the company are not waiting for offers in this regard. One or two electricians arrived in town yesterday in the interest of their respective systems. While the company will have the light distributed in the city as soon as practicable, it will not be working over in ten days or even three weeks, as is talked of about town. It is taken to accomplish the work, and the company do not propose being in too much of a hurry, but will endeavor to give satisfaction with the light and take advantage of all the improvements. The capital stock has been liberally subscribed.
