3. Bills affecting expenditure of public money, &c., introduced, Resolutions being subsequently adopted and referred to Committee of the Whole upon such Bill, 156, 157, 169.
4. Bill introduced and read *pro forma* before the consideration of the Speech from the Throne, 11.
5. Bill to amend an Act of the same session, 274, 293.
6. Bill read a second time at the same sitting, 420, &c.
7. Bill read a second time and committed forthwith, 37, 114. Referred to a Standing Committee, 202, 236. To a Special Committee, 207.
8. Order for second reading of a Bill discharged and Bill withdrawn, 221, 399. Motion for second reading of a Bill negatived, 261. Withdrawn, 201, 441, 450. Ruled out of order, 202.
9. Progress reported by the chairman of Committee of the Whole on a Bill, 37, 114, 136, 201. Bill to be considered again the same day, 136.
10. Amendment moved on motion for second reading of a Bill, 125.
11. Debate on motion for second reading of a Bill interrupted by order for Private Bills, 128.
12. Bill amended in Committee of the Whole considered immediately, 115, 172.
13. Order for House in Committee on a Bill discharged and Bill referred to a Standing Committee, 201. Transferred to Government Orders, 297.
14. Committee of the Whole on a Bill rises without reporting, 261.
15. Bill recommitted on third reading, 264, 402, 407.
16. Motion for third reading of a Bill withdrawn, 408.
17. Bill passed through several of its stages at the same sitting, 114. All its stages, 335, 420, 422, 426, 431, 433.
18. Bills discharged from the Order Paper, 407.
19. Bills from the Senate read the same day as they are brought down, 275. On a subsequent day, 264, &c.
20. Amendments of the Commons to Bills from the Senate, 286, 469. Senate agrees without amendment, 313.
21. Amendments of the Senate to Bills from the Commons considered immediately, 469. On a future day, 375. Agreed to without amendment, 470.
22. Bills assented to during the session, 222, 223, 342, 344. At the close, 523, 524.
