Mr. Casselman, for Mr. Harris, from the Select Standing Committee on Railways, Canals and Telegraph Lines, presented the Third Report of the said Committee, which is as follows:—

Your Committee have had referred to them Bill No. 33, An Act respecting The Montreal Central Terminal Company, and Bill No. 37, An Act to incorporate Forth Smith-Fitzgerald Railway Company.

As the promoters in each case have intimated that they do not intend to proceed further this session, your Committee recommend that the said Bills

Nos. 33 and 37 be withdrawn.

With respect to Bill No. 33, An Act respecting The Montreal Central Terminal Company, your Committee recommend that \$204 of the Fees and Charges paid be refunded.

Mr. Manion, a Member of the King's Privy Council, for Mr. Gordon, presented,—Return to an Order of the House of the 21st March, 1932, for a Return showing:—

1. When projects to aid unemployment in the province of Quebec for the year 1931, were submitted to the Federal Government for approval, and what

projects were so approved.

3. Projects approved for the year ending March 31, 1932, and the dates of approval.

4. What projects, if any, were approved in the years 1931 and 1932, to the 31st of March, in the county of Charlevoix-Saguenay, and for what amount in each case.

Also,—Return to an Order of the House of the 18th April, 1931, for a Return showing:—

1. In what counties of the province of Quebec amounts were granted for municipal and provincial works pursuant to the Unemployment Relief Act.

2. Amounts authorized for each county.

3. Number of requests for money from municipalities in the province of Quebec for unemployment relief works refused by the Federal Department of Public Works.

And also,—Return to an Address to His Excellency the Governor General of the 21st March, 1932, for a copy of all correspondence and resolutions in possession of the Labour Department, forwarded by the Quebec Government and Municipalities, requesting delay in carrying out public works in connection with the unemployment relief.

Mr. Cahan, a Member of the King's Privy Council, presented,—Return to an Order of the House of the 18th April, 1932, for a Return showing how many inquiries were requested in connection with active political partisanship since August, 1930, (a) by the defeated Conservative candidates from the province of Quebec; (b) by the defeated Conservative candidates from the other eight provinces of the Dominion; (c) by the Conservative members from the province of Quebec; (d) by the Conservative members from the other eight provinces of the Dominion.

And also,—Return to an Order of the House of the 9th May, 1932, for a copy of all paysheets, accounts, memorandums, letters and other documents, regarding the expenditure of money under the Unemployment and Farm Relief Act, 1931, in connection with extension to breakwater at Rockdale, Nova Scotia.
