## Inquiries of the Ministry FORESTRY

INQUIRY AS TO RESTORATION OF DOMINION-PROVINCIAL AGREEMENTS

On the orders of the day:

Mr. H. W. Herridge (Kootenay West): I wish to address a question to the Minister of Forestry and Rural Development. In view of the charge made by Mr. D. I. Crossley, president of the Canadian Institute of Foresters at their annual meeting at the Chateau Laurier hotel yesterday that the government is inactive in the face of an urgent need to increase forest productivity, and that it has resisted all attempts to restore the federal-provincial forestry agreements terminated over a year ago, can the minister inform the house what are the government's intentions with respect to these agreements?

**Mr. Speaker:** Order. I have the impression that this question is of such a general nature as to require the minister to make a statement on motions, and for this reason I suggest to the hon. member that his question should not be asked at this time.

**Mr. Herridge:** With all respect Mr. Speaker, there is an important conference taking place in Ottawa now, and those attending are most concerned about federal-provincial agreements with respect to forestry development in this country. The question is urgent from their point of view, and I have been requested by several good sources to ask this question.

Hon. Maurice Sauvé (Minister of Forestry and Rural Development): These agreements came to an end on March 31, 1967, and no consideration is being given to their re-establishment.
