POLLUTION

INVITATION FROM ONTARIO TO PARTICIPATE IN CONFERENCE WITH UNITED STATES GOVERNORS

Mr. G. H. Aiken (Parry Sound-Muskoka): My question is intended for the Minister of Energy, and Resources. Has the hon. gentleman responded to an invitation from the Ontario government to attend a conference with United States governors on pollution control measures affecting the Great Lakes?

Hon. J. J. Greene (Minister of Energy, Mines and Resources): That invitation is being considered. We are holding discussions with United States federal officials in connection with a high-level federal conference which at some stage would embrace the provinces in connection with the international control of pollution and water quality. Certainly, all these initiatives should be dovetailed; we should co-ordinate these efforts because it will take a co-operative effort on the part of the provinces and the authorities to achieve the arrangements which will be most beneficial.

Mr. Aiken: Since the Ontario government was not represented at preliminary discussions on the IJC report, and there now seems to be some hesitation about the Ontario conference, will the minister make sure that talks on this very important matter are carried on in the presence of all interested governments?

Mr. Greene: As I have stated earlier, the IJC report will be the basis, we hope, of the federal negotiations and consultations. Preliminary discussion has taken place and we hope that in the arrangements ultimately to be made the Ontario representatives will be a party to any negotiations which take place. As I have often said, under our constitution Ontario will have to participate in the implementation of any agreement with the United States on the Great Lakes.

MANPOWER

INCREASE IN EMPLOYABLES ON RELIEF ROLLS
—ASSISTANCE TO MUNICIPALITIES

Mr. S. Perry Ryan (Spadina): My question is directed to the Minister of Manpower and Immigration. Hon. H. A. Olson (Minister of Agriculture): There have been many policy announcements made from time to time and the aggregate of these announcements is the over-all policy, which may be amended again from time to time.
