FORD MOTOR COMPANY—POSSIBILITY OF SHUTDOWN BECAUSE OF U.S. POLLUTION CONTROLS—SUGGESTED CONSULTATION WITH AMERICANS ON DISTRIBUTION AND ECONOMIC DISLOCATION

Hon. George Hees (Prince Edward-Hastings): Mr. Speaker, I have a question for the Minister of Industry, Trade and Commerce, but in his absence I will address it to the Acting Prime Minister. Has the government given consideration to holding meetings with the government of the United States with the aim in mind of persuading that government to permit the Ford Motor Company to distribute 1973 model cars to its agencies with the proviso that these 1973 models not be sold until the completion of the new tests being carried out by the United States Environmental Protection Agency?

Hon. C. M. Drury (Acting Prime Minister): This is quite an interesting suggestion, Mr. Speaker, and I will see that it is passed on to the Minister of Industry, Trade and Commerce.

Mr. Hees: Mr. Speaker, has the government also considered holding meetings with the United States government with the object of avoiding a dislocation of the production of the Ford Motor Company both in Canada and in the United States because of the very serious effects such dislocations will have on the economies of both countries?

Mr. Drury: Mr. Speaker, I think the hon. gentleman is aware that the government of Canada is meeting fairly continuously on a number of trade matters with the United States, and that preoccupation with avoiding dislocation of the motor car industry is of just as great concern to them as to us.

Mr. Hees: In view of that very general non-answer, and because of the great seriousness of the dislocation which can result from the Ford Motor Company having to stop production, will the government make it a very special point with the government of the United States to avoid such dislocation?
