#### TRANS MOUNTAIN PIPELINE—TRANSPORTATION OF ALASKAN CRUDE OIL—ENVIRONMENTAL SAFEGUARDS

Mr. Benno Friesen (Surrey-White Rock-North Delta): Madam Speaker, I have a question for the Prime Minister. In the talks and correspondence with Trans Mountain Pipe Line officials regarding the use of their facilities to transport Alaskan crude, I should like to ask the Prime Minister what environmental safeguards have been discussed in relation to this project.

**Right Hon. P. E. Trudeau (Prime Minister):** Madam Speaker, I am not aware of any recent talks. I have not been informed of any recent exchanges on this particular point. As the hon. member knows, this government has always expressed the hope that Trans Mountain would not be the preferred route, but a parallel line along the Foothills line for gas would be built to transmit oil from Prudhoe Bay to the United States. That is still our preferred course.

**Mr. Friesen:** Madam Speaker, I have a supplementary question. The Prime Minister seems clueless about it now, but he certainly talked a lot about it during the campaign. For my constituency, this proposal would be an improvement over some of the other proposals that have been talked about, because it would get ships out of the inland waters. It would mean that not only tankers but supertankers would come down the coast. In light of what the Prime Minister said during the election campaign, what is the level of commitment of the Liberal government toward stopping the tankers coming down the west coast?

**Mr. Trudeau:** Madam Speaker, the hon. member is agreeing with the position we took during the campaign. It was to the effect that the all overland route should have been pushed by the Conservative government as it was pushed by our government.

Mr. Nielsen: Which is what we did.

**Mr. Trudeau:** It is still our hope that this will be the route which will succeed. I am just informing the hon. member that I am not aware of any current information on that matter. I would have to defer to the minister.

Because the list is quite detailed, I think it would be more informative through that means of communication.

Madam Speaker: I recognize the hon. member for a short supplementary question.

Miss Jewett: Madam Speaker, I would say to the minister that I hope the list will be available soon, as the secret conference begins on Tuesday.
