been put on the table and have not been challenged by either the Minister or the Government.

That is the question which, unfortunately, the resignation of the Minister does not answer. We have seen quite clearly that the Prime Minister was originally prepared to hide behind the ADRG and is now prepared to hide behind an independent, impartial arbiter. The arbiter is the House of Commons. It is the Parliament of Canada which tells young Canadians that they can aspire to be political leaders and to come into the House of Commons under all political Parties, that they can aspire to politics because it is an honourable profession. Unfortunately, in the last two weeks the Deputy Prime Minister has been aided and abetted by the Prime Minister who was pulling the strings from overseas. He was leading the charge in the attempt to cover up and stonewall on this issue.
