APARTHEID

SOUTH AFRICA—PRIME MINISTER'S SCHEDULED MEETING WITH PRESIDENT OF AFRICAN NATIONAL CONGRESS

Mr. Bill Attewell (Don Valley East): Mr. Speaker, my question is for the Secretary of State for External Affairs. It concerns communication with the South African Government. The Prime Minister visited several front line States a few weeks ago. Yesterday I read a report that the Prime Minister may meet with a senior African National Congress spokesman here in Ottawa. In our earnest efforts to help bring about an end to apartheid can the Secretary of State assure us that constructive dialogue is still taking place with President Botha and the South African Government? Will he, or the Prime Minister, be visiting South Africa this year or next?

Right Hon. Joe Clark (Secretary of State for External Affairs): Mr. Speaker, neither the Prime Minister nor I have any present intention to visit South Africa. However, if it would serve a constructive purpose toward bringing an end to apartheid, I would certainly be prepared to undertake a visit of that nature. The Prime Minister and I will both be meeting with Mr. Oliver Tambo, the President of the African National Congress, when he is here sometime over the next several weeks.

With regard to relations with South Africa, embassies are open in both countries. Despite my natural modesty, I draw to the attention of the Hon. Member remarks in a speech I made in Montreal the other day when I said:

—we must all seek means to keep lines open to all parts of South Africa—black and Botha, Buthelezi and Tambo, Mandela and Afrikaner. The worst result would be for us to cause the Botha Government to change its view, and then not have the channels to effect that change.

IMMIGRATION

PORTUGUESE REFUGEES—ALLEGATIONS CONCERNING CONSULTANTS AND OFFICIALS

Mr. Sergio Marchi (York West): Mr. Speaker, my question is for the Minister of Employment and Immigration. It concerns the revelations that Canadian immigration officers in Portugal are linked with unscrupulous consultants in an extensive immigration scam. We have an immigration policy that is misguided, a program paralyzed by confusion, and now allegations of visa officers peddling visas for \$4,000.

Given that I urged the Minister of State for Immigration last May to conduct a full investigation and to take action on the ring of unscrupulous consultants behind the movement of Portuguese refugees, I want to ask the Minister why the Government failed to take this affair seriously. Why has there been no action or charges laid by the RCMP after a full year of investigation? Why did the Government appoint this morning a second RCMP investigation when we already have one which is ongoing? Canadians want action, not whitewashing.
