ALLOTTED DAY, S. O. 82—BANK CHARGES—CONCURRENCE IN REPORT OF STANDING COMMITTEE

Mr. John R. Rodriguez (Nickel Belt) moved:

That the Nineteenth Report of the Standing Committee on Finance and Economic Affairs, respecting bank charges, presented to the House on Monday, June 6, 1988, be concurred in, and that the adoption of this motion shall not be considered to be a question of confidence in the government.

Mr. Nystrom: I rise on a point of order, Mr. Speaker, if I can get the Parliamentary Secretary's attention across the way. We have done the normal consulting around the Chamber. We would like the vote deferred until six o'clock Monday, if possible. I understand this will take unanimous consent of the House.

I have done the consulting with the Government's Deputy House Leader of the Liberal Party. We all agree with that. We might as well do it now.

Mr. Hawkes: As usual, Mr. Speaker, this reflects the accuracy of our conversations. Yes, we think it would be in the House's best interest to defer the vote to Monday. We do concur.

Mr. Rodriguez: Mr. Speaker, in beginning the debate on this motion I want to point out a very important aspect of it. Normally a vote on an allotted day is considered a question of confidence in the Government. I want to make it crystal clear that in the motion which I have put forward today it is specifically spelled out that a vote in favour of the motion is not to be considered a lack of confidence in the Government. That is justifiable because the motion is to concur in the report of the Standing Committee on Finance and Economic Affairs, which committee represents all sides of the House.

As a matter of fact, the Conservative Chairman was dubbed a socialist by the Bankers Association. Robert MacIntosh called the Member for Mississauga South (Mr. Blenkarn) a socialist. I am prepared to adopt him. I will baptize him and call him a socialist for this interregnum. He is indeed a red socialist.

The report represents the opinions, after study, of all sides of the House. The motion I put forward reflects the view arrived at in the committee. Conservative Members may try to hide behind the veil that they must vote against this motion in order not to show a lack of confidence in the Government. I want to make that clear. The motion specifically says:
