## **IMMIGRATION**

Mr. Jim Karpoff (Surrey North): Mr. Speaker, I have a petition signed by a large number of people from Surrey which points out that family class and assisted relatives have always been an historically important part of immigration into Canada because they have relatives that can assist them with employment, housing and learning Canadian language and customs.

The petitioners point out that the present proposals of this government would severely restrict family class and assisted relatives from obtaining immigration visas. They ask the government to change their priorities so that family class and assisted relatives are assured first priority in immigration into Canada.

#### BILL C-91

Mr. Howard McCurdy (Windsor—St. Clair): Mr. Speaker, I am pleased to have this opportunity to bring before this House a petition signed by a number of Canadian citizens who are extremely angry that Bill C-22 should have been introduced in the first place. This bill erodes the Canadian institution of compulsory licensing which provided inexpensive drugs. We are now confronted with Bill C-91.

In short, the petitioners ask that Bill C-91 be with-drawn and Bill C-22 be revoked.

It is a pleasure to submit this petition because my party and I support that view.

## **CANADA POST**

Mr. Vic Althouse (Mackenzie): Mr. Speaker, I have a petition from my riding at Raymore which points out that post offices are the backbone of many rural communities.

The petitioners call upon Parliament to support Canada's rural way of life by supporting the maintenance of rural post offices and postal services and to reject the Conservative agenda of cutbacks and closures of those services.

#### YOUNG OFFENDERS ACT

Mrs. Edna Anderson (Simcoe Centre): Mr. Speaker, I have a couple of petitions here, one which is from many people in my riding of Simcoe Centre. These petitioners request that Parliament revise the laws of Canada to replace the Young Offenders Act with an updated

juvenile delinquents act with a lowered maximum age of 13 years.

Hon. Paul Wyatt Dick (Minister of Supply and Services): (a) With respect to contracts in excess of \$100,000 which have been sole sourced, 18,238 contracts were awarded through Supply and Services Canada (SSC) since 1985.
