NORTHWEST TERRITORIES—INQUIRY AS TO DECISION ON SELF-GOVERNMENT

Mr. Frank Howard (Skeena): Mr. Speaker, may I direct a question to the Minister of Indian Affairs and Northern Development. Is he now in a position to announce government policy with respect to self-government for the Northwest Territories?

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): No, Mr. Speaker, we are not ready at this time, but I hope that we will be in a position to do so before the end of the summer.

Mr. Howard (Skeena): Mr. Speaker, I rise on a question of privilege which is related to the misleading way the minister has answered our questions.

Some hon. Members: Oh, oh.

Mr. Howard (Skeena): My question of privilege relates to the manner he has answered questions of this nature both recently and in the past. For example, on January 21, 1969, the minister said, as reported on page 4551 of Hansard:

-I have taken a decision on this matter and submitted a proposal to the cabinet. I hope it will receive approval within the next weeks and I expect to be in the Northwest Territories, to announce the new policy, in early February.

When asked similar questions on other occasions his answer has been "soon", "fairly quickly", and so on. I submit that the minister has been misleading the house by making answers of that kind with respect to self-government for the Northwest Territories.
