current year referred, 96. House goes into committee, 109. Report two Resolutions; Amendment proposed to 1st (Frontier volunteer force), and negatived; Resolutions agreed to, 126. Message with Estimates for completion of the Service of 1864-65, and on account of the 1st Quarter of 1865-66, including Fortifications, referred, 211. House goes into committee, 212, 213. Report two Resolutions; Motion, in amendment to 1st (Supplies to 30th Sept.), that while the House will cheerfully grant the Supplies, it regrets that there should have been any departure from the established practice of basing the appropriations upon detailed Estimates, negatived; Resolution agreed to, 227. Motions, in amendment to 2nd Resolution (\$1,000,000 for Fortifications), that the House cannot authorize a large expenditure for permanent defences, until it is informed what works are to be constructed, and the proportion of the cost thereof to be paid by this Province,—and expressing an opinion that no portion of the grant should be expended until detailed Estimates shall have been submitted to Parliament,—severally negatived; Resolution agreed to, 228.—
