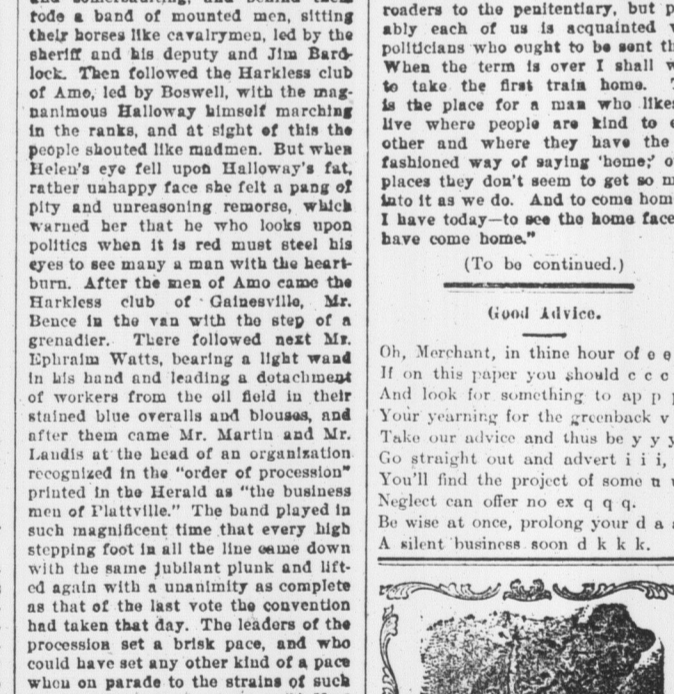
World's News. Mrs. Robert Porter, of Boston, Yarmouth, fell dead while scrubbing a floor on Saturday evening.
