P.C. 3027, 3rd November, 1917. Re status of applicants for homestead entries as

to nationality.

By leave of the House,

Mr. Rowell moved, seconded by Mr. Ross, That the recommendation contained in the third report of the Special Committee, appointed on the 10th day of April, 1918, to consider and report upon the Pension Board, the Pension Regulations and the sufficiency or otherwise of the relief afforded thereunder, the Pension lists in force in Canada for disabled and other soldiers and the dependents of those killed while on active service, and any other matters relating thereto or connected therewith, be commended to the consideration of the Government.

And a Debate arising thereupon;

Sir George Foster moved, (under Rule 36), seconded by Mr. Carvell, That the House do now proceed to Government Orders;

And the question being put on the said motion; It was resolved in the Affirmative.

The House, according to Order, proceeded to take into consideration the Amendments made by the Senate to the Bill, No. 69, to amend the Criminal Code, and the same were read, as follow:—

- 1. Page 1, line 4.—Leave out clause 1.
- 2. Page 1, line 19.—Leave cut clause 2.
- 3. Page 2, line 1.—Leave out clause 3.
- 4. Page 2, line 11.—In clause 4 leave out section 220A.
- 5. Page 2, line 19.—After "who" insert ", in the home of a child,".
- 6. Page 2, line 21.—For "a" substitute "such".
- 7. Page 2, line 22.—For "a" substitute "such".
- 8. Page 2, line 23.—For "a" substitute "such".
- 9. Page 2, lines 36 and 37.—Leave out "organized Child Welfare Society or Association with like object" and insert "recognized society for the protection of children or an officer of a juvenile court,".

The said Amendments, being read a second time, were agreed to.

Ordered, That the Clerk do carry back the Bill to the Senate, and acquaint their Honours, That this House hath agreed to their Amendments.

The House, according to Order, proceeded to take into consideration the Amendments made by the Senate to the Bill, No. 85, to amend The Income War Tax Act, 1917, and the same were read, as follow:—

1. Page 1, line 31.—After "Canada" insert "or employed in Canada".

2. Page 1, lines 32 and 33.—Leave out the words "and upon the income received by any person from any source within Canada".

The said Amendments, being read a second time, were agreed to.

Ordered, That the Clerk do carry back the Bill to the Senate, and acquaint their Honours, That this House hath agreed to their Amendments. Mr. Maclean (Halifax) Acting Minister of Finance, accepting the amendments, with a protest against the right of the Senate to make amendments to Money Bills).

On motion of Sir George Foster, seconded by Mr. Maclean (Halifax),

Ordered, That the Order for the second reading of the Bill, No. 70, from the Senate, intituled: "An Act to consolidate and amend the Railway Act," be discharged and the Bill withdrawn.
