LAKE MANITOBA—ESTABLISHMENT OF BEACH PARKS

Question No. 1,417—Mr. Simpson:

1. In what areas were the three small beach parks established on Lake Manitoba as indicated at page 27 of the 1968-69 Annual Report of the Department of Regional Economic Expansion?

2. What were the total amounts of federal government moneys spent on each of these beach parks?

Mr. Martin P. O'Connell (Parliamentary Secretary to Minister of Regional Economic Expansion): 1. Lili Bay, The Narrows, and Steep Rock.

2. Nil. Through an editing error the Department's Annual Report indicated that these parks had actually been established, whereas it should have indicated only that preliminary investigative work was done and a decision taken that parks should be developed at these sites. Since the preparation of the report, there has been a further decision that work on the parks will not be done as a part of the Interlake Fred Plan but will be carried out by the provincial government in the future.

1. How many companies, building plants in designated areas, are controlled outside of Canada?

2. How many are Canadian companies?

3. What was the cost in dollars for machinery and equipment purchased outside of Canada by companies controlled outside of Canada?

4. What was the cost in dollars of machinery and equipment purchased in Canada by foreign subsidiaries?

5. What percentage of machinery and equipment was obtainable in Canada at competitive prices?

Question No. 1,448—Mr. Broadbent:

1. What were the total wage and salary payments made by Canadian Pacific to its Railway employees for each year since 1960?

2. What were the total wage and salary payments made by CPR to its employees whose wages and salaries were determined by collective agreement for each year since 1960?

3. What were the total wage and salary payments made by CPR to its employees whose wages and salaries were determined other than by collective agreement?

4. (a) What was the average number of employees of CPR for each year since 1960 (b) what was the average number of employees of CPR covered by collective agreements in each year since 1960?

5. (a) What were the average annual earnings of employees of CPR covered by collective agreements in each year since 1960 (b) what were the average annual earnings of employees of CPR not covered by collective agreements?

6. What were the actual amounts, included in direct payments to employees, for vacation pay, for general holidays, for sick leave and for personal leave and what proportion of total labour costs do these amounts represent?

7. What were the actual amounts paid by the Company each year since 1960 or since the inception of the Job Security Agreements into the Job Security Fund and what proportion did this amount represent of total labour costs?

8. What was the Company's contributions to benefit plans including pension plans, to health plans including provincial medicare plans, for each year since 1960, and what proportion do these amounts represent of total labour costs?

9. Assuming a definition of total labour costs to be all direct and indirect payments to employees including the Company's contributions to Workmen's Compensation, to Unemployment Insurance and to the Canada Pension Plan, what proportion of total costs were represented by labour costs for each year since 1960?
