ROCHDALE COLLEGE—POSSIBLE USE AFTER FORECLOSURE

Mr. Reg Stackhouse (Scarborough East): Mr. Speaker, my question is for the Minister of State for Urban Affairs and it is supplementary to an earlier question asked about Rochdale College. In light of the letter that has been sent by the Metropolitan Toronto Police Commission, and in light of the opinion given at the coroner's inquest, has the minister any plans for devoting Rochdale College to a more socially constructive purpose after foreclosure than the one for which it is now being used?

Hon. Ron Basford (Minister of State for Urban Affairs): Mr. Speaker, as I said, we are pursuing foreclosure with all the speed that the courts will allow, and that is as fast as it is possible to go. It would be premature to determine any use for the building prior to our gaining possession of it pursuant to the foreclosure action.

BUSINESS OF SUPPLY

ALLOTTED DAY S.O. 58—NON-CONFIDENCE MOTION— CONDEMNATION OF SALE OF POLYMER CORPORATION BY GOVERNMENT

That this House condemns the sale by the government on July 27, 1972, by Order in Council P.C. 1972-1715 of the whole of the capital stock of Polymer Corporation Limited to Canada Development Corporation.

He said: Mr. Speaker, the motion that we are dealing with today has been deliberately couched in very careful terms so as to confine this debate to a very specific issue, namely, the sale by the government of the whole of the capital stock of Polymer Corporation Limited to the Canada Development Corporation. This whole matter has been shrouded in secrecy because of the almost paranoiac refusal of the government to make the disclosure. The information has been suppressed.
