FUNDS SENT TO UNITED STATES BY ORGANIZED LABOUR AND UNITED STATES CONTROLLED CANADIAN COMPANIES

Question No. 965-Mr. Alexander:

To the knowledge of the government, how much money was sent to the United States last year (a) by organized labour in Canada (b) [Mr. Allmand.] by Canadian companies controlled or owned by United States interests?

Mr. Herb Breau (Parliamentary Secretary to Minister of Industry. Trade and Commerce): Statistics Canada reports that: (a) In 1969, the last year for which figures are available, the total dues and assessments paid to international union headquarters in the United States on behalf of Canadian members, as reported under Part II of the Corporations and Labour Unions Returns Act, amounted to \$41,469,000 distributed as follows: Per capita, \$26,240,-000—63.3 per cent; Strike benefit assessments, \$6,708,000— 16.2 per cent; Health and welfare assessments, \$4,286,-000—10.3 per cent; Death benefit assessments, \$2,200,000— 5.3 per cent; Initiation fees, \$1,006,000—2.4 per cent; Fines, work permits and other assessments, \$1,029,000—2.5 per cent.

NOTE: These payments do not include interest earnings and dividends on investments by international unions as these are not reported under the Act.

(b) In 1972, it is estimated that Canadian companies controlled or owned by United States interests paid, net of withholding tax, about \$1,460 million to United States residents for payment of interest, dividends, branch profits and business services.

HOSTING SERVICE OF YOUNG VOYAGEUR PROGRAM

Question No. 996-Mr. Nielsen:

Of the 40 university students who will be participating in the program of welcoming groups of Young Voyageurs to the National Capital Region this summer (a) in which provinces or territories are such students normally resident and, in each case, how many (b) what will be their period of employment (c) what will be their wages?

Hon. James Hugh Faulkner (Secretary of State): (a) The Ottawa Regional Office of the Public Service Commission is responsible for recruiting and hiring students for summer employment. Thirty-three students have been hired by that office for the Hosting Service of the Young Voyageur Program. Twenty-six of these students are from the province of Ontario and seven are from Quebec. (b) Five students will be employed from May 1st to August 31. 1973; the remaining twenty-eight will work from May 15 to August 31, 1973. (c) The salary scale for students employed in the Hosting Service of the Young Voyageur Program varies from \$1.90 per hour to \$5.15 per hour. Rates are paid in respect of the number of accredited years of schooling relevant to the student's present course. There is an additional rate of 11 cents per hour to 16 cents per hour for extra duty pay.
