The Crown's financial involvement is limited to annual contributions toward the operating costs of the service over a maximum period of seven years. Formed in October 1975 as a non-profit organization without share capital, the equity of the corporation is limited to the net value of the fixed assets which amount to \$5,773.00. The reason for the contribution was to promote the development of an organization that could
